New Dimensions School of Hair Design Policy

New Dimensions School of Hair Design will contact student regarding their need relative to the disruption in family financial situations due to the Corona Virus Pandemic. New Dimensions School of Hair Design will ascertain these needs in allocating disbursement of grant funds from the U.S. Department of Education under the CARES Act. After need is ascertained for each student, New Dimensions School of Hair Design will disburse funds evenly across the current active student body. Fund amounts will be disbursed to those who have applied and processed a FAFSA, financial aid application, paying students equally. All active and LOA students from 03-20-2020 forward who are Title IV eligible may receive funds.

Once a student signs the Certifying Statement, they will then be eligible to receive their disbursement from the CARES Act Relief Fund. The Certifying Statement and copy of the check will be maintained in the student file for further proof of disbursement.

New Dimensions School of Hair Design will also keep a file with all HEERF related information, to include: Grant.gov emails, copies of DJA spreadsheets with eligible student and amounts, cash request documents, the school policy, and other information related to HEERF.

The total per student amount is being based on \$22,279 (student amount) / total number of eligible student = disbursement amount.

NEW DIMENSIONS SCHOOL OF HAIR DESIGN

Each student was presented with the Certifying Statement to determine grant eligibility. The statement was to inform each student of what the Emergency Financial Aid Grant to Students was intended for. Upon reading the statement the student responded to the questions with yes/no as to whether they had a disruption in the family's financial situation due to the COVID-19 pandemic. This allowed New Dimensions School of Hair Design to answer all questions to the student may have had. It also allowed the school to determine the number of eligible students.
